## MONTHLY BENEFIT PAYMENTS CONSENT FOR THE DIRECT TRANSFER OF PAYMENTS INTO OVERSEAS BANKING ACCOUNTS

We have been informed by our bankers that all payments by swift (Electronic Transfers) to overseas banks now require the SWIFT address code of the member's own branch plus the IBAN number. This should ensure a faster transfer of funds at the minimum cost.
