PROCEDURE FOR THE COMPLETION AND REGISTRATION OF A "CONSENT TO ACT AS SURETY IN RESPECT OF A HOUSING LOAN" FORM

- 1. Application must be on the official application form.
- 2. If <u>THE COMPANY</u> is granting the member the loan, a letter on company letterhead stating the amount of the loan being granted to the member, must be submitted with an application form.
- 3. If a <u>FINANCIAL INSTITUTION</u> is granting the member the loan, a copy of the loan application must be submitted with the Fund's application form.
- 4. The application form must be completed in full and signed by the member and two witnesses.
- 5. All alterations must be initialled by the member and the witnesses. No changes / alterations made with a correction fluid will be accepted.
- 6. The member's identity number must be the identity number with which the member pays contributions to the Fund. Kindly attach certified copy of the member's identity Document.
- 7. An acknowledgement from the Fund will be forwarded to the company or the financial institution.
- 8. Once the above requirements have been met, the application form together with all the required documentation must forwarded to the Fund for registration.
- An acknowledgement from the Fund once the application has been registered will be forwarded to the company or the financial institution.

Your attention to these requirements / procedures will enable the Fund to give employees, members and financial institutions prompt and efficient service.
